**Sergeant at Arms: Mark, N6ARP:** Mark had no report.

**Board Members: Paul, W6UHF, Scott, N6CIC, and Brendon, NK6M. Bill, AE6J was not present.**

Paul and Brendon had no report. Scott reported solar cycle 25 had 36 sunspots and this is encouraging. Index was 86 and growing. HF 17 and 15 meters is opening. Hopefully HF will be improving overall.

**Equipment/Mt Oso: Patrick, KG6AZZ**

Patrick and Lucian made a trip to Mt. Oso on Saturday April 17, 2021. A general maintenance was completed on the equipment and shack. The building was cleaned, and additional mouse bait was put out. We sprayed round up for weed control. The 440 fusion repeater was reset and both analog and digital modes are now operational. There was some light wind and it was observed that the top of the new VHF antenna was moving and occasionally would hit the tower support. This may be some of the cause of the "crackle". We need to consider attaching a top support for the antenna. A stop was made at the packet site. We did some evaluation of what equipment is needed to bring it up to "r56" standards. This is a requirement of the Bureau of Reclamation.

The April ARES meeting was Saturday April 3, 2021 (10:00am to Noon). The meeting was held over ZOOM. There was a presentation by Lucian, KF6NPG on working community events and the equipment that you would need. Patrick, KG6AZZ led a discussion on software defined radios. The next meeting is Saturday May 1, 2021 and the ZOOM link will be sent out a couple of days before the meeting. There will be officer's reports, general discussion on the upcoming County wide hospital drill and community events.

**Community Events: Lucian, KF6NPG**

The Turlock Lake Road Race has been cancelled as their permit application was denied, it may be rescheduled for Saturday June 19, 2021. The Regalado Road Race is scheduled for Sunday May 30, 2021 (pending permit approval). The Copperopolis Road Race is scheduled for Saturday June 5, 2021. We will continue to monitor with the event coordinators and let everyone know of any updates.

**Ham Cram: John, K6JRO**

John said that the recent Ham Cram held on Saturday April 17, 2021 was a raging success. He was assisted by Brendon, NK6M, Paul, W6UHF and Ed, KF6FIR. There were 15 total students/test takers (9 technicians, 5 generals and 1 extra) and there was a 100% pass rate. They operated under COVID restrictions (mask wearing, social distancing and extra cleaning). All of the test paperwork has been submitted to ARRL. The next Ham Cram is scheduled for Saturday August 14, 2021, unknown at this time of what the COVID restrictions will be.

Wally said things are opening slowly and Calaveras County is in the orange tier however, there are still restrictions for groups that gather. He brought up the challenges of possible requirements of vaccinations or negative test, masks, handwashing station and social distancing. There was much discussion regarding field day. It was mentioned that many clubs (including TARC) are not sponsoring club field days. Due to the uncertainty of what would be required it was the consensus that the club not sponsor a field day this year. We would follow the ARRL guidelines (as we did last year) that allow club operators to document contacts and send them into the club and the club would send in the completed contact list to ARRL.

A motion was made by Ed, KF6FIR to do field day the same as we did last year and there was a second by Paul W6UHF. The motion was passed with no opposition. Ed, KF6FIR volunteered to be the collector of contacts made by club members and would tally them and send in on behalf of the club to ARRL. Ed asked that contact lists submitted to him be typewritten. You can submit them in word or similar type format or in a spreadsheet type format. This will allow him to cut and paste the contacts into the tally sheet that would be send in to ARRL. Ed's email is ed@kf6fir.net .

People may want to go up to the field day site on their own, just remember that it would not be a club sponsored event.

## ARRL EC-001 course

### ARRL EC-001 Emergency Communications Course

If you need to take the ARRL Emergency Communications Course (EC-001) Stanislaus ARES can help. The EC-001 workbook is out of print, however The Indian River County ARES has all of the study information (including test and answers) posted on their web site. Recent amateurs who have taken the test have printed out the test questions and answers and have studied like they would for a ham cram. Pass rate has been about 100 percent.

\*\*\*The ARRL has updated this course. There are some content differences, however members who have used this to prepare for the challenge exam have been successful.\*\*\*

Here is the web site to study for the ARRL Introduction to Emergency Communications Course challenge examination (EC-001):

Go to [www.ircares.org](http://www.ircares.org) This is the web site for the Indian River County ARES. Once you are on the web site click on the training and reference tab. Then click on the ARRL Introduction to Emergency Communications (EC-001) tab. That will take you to the course information.

Once you complete this on-line study you can arrange with Stanislaus ARES to take the ARRL test. We generally give the test at a ham cram session or before or after the monthly ARES meeting. Please e-mail Pat KG6JXZ at [kg6jxz@charter.net](mailto:kg6jxz@charter.net), or Lucian KF6NPG at [kf6npg@aol.com](mailto:kf6npg@aol.com) or John K6JRO at [k6jro@arrl.net](mailto:k6jro@arrl.net) to arrange to take the test. **There is a \$15.00 test administration fee payable to ARRL.**

You can also access the updated ARRL EC-001 course at the ARRL website. Go to [www.arrl.org](http://www.arrl.org). Once there click on the licensing, education and training tab. Then click on the online course catalog tab and

look for the EC-001 course. It states that it takes about 45 hours to complete the course over 9 weeks. Once you complete the ARRL course you can take the exam online. From what I can see there is no charge to take the course or exam. You have to take the course before you can take the exam.

You cannot take the challenge exam online.



## Featured Article

### First-Time Exam Applicants Must Obtain FCC Registration Number Before Taking Exam

Beginning May 20, 2021, all amateur examination applicants will be required to provide an FCC Registration Number (FRN) to the Volunteer Examiners (VEs) before taking an amateur exam. This is

necessary due to changes the FCC has made to its licensing system.



Amateur candidates who already have an FCC license, whether for amateur radio or another service, and already have an FRN may use the same number. All prospective new FCC licensees, however, will be required to obtain an FRN *before* the examination and provide that number to the volunteer examiners on the Form 605 license application. An FCC instructional video provides step-by-step instructions on how to obtain an FRN through the FCC's Commission Registration System (CORES).



The FRN is required for all new applicants to take an amateur exam and is used afterward by the applicant to download the license document from the FCC Universal Licensing System (ULS), upgrade the license, apply for a vanity call sign, and to submit administrative updates (such as address and email changes) and renewal applications.

In addition, after June 29, all applications will be required to contain an email address for FCC correspondence. Applicants will receive an email directly from the FCC with a link to the official electronic copy of their license whenever a license is issued or changed. ARRL VEC suggests that those without access to email should use the email address of a family member or friend. Licensees will be able to log in to the ULS using their FRN and password to download the latest version of their license at any time. The FCC no longer provides paper license documents.
